## RE-EVALUATION

Though many of you realize the importance of updating the patient complaints upon re-evaluation you may have a hard time presenting your patient with an entire Health Questionnaire each time you do a re-evaluation.

Now, when the patient complaints are the **ONLY** thing to change (e.g. *The patient has not been into the office for a few months and is coming in with a new complaint but the original history remains the same*), you can easily update and amend the patient's history on re-evaluation using **ONLY** pages 1&2 of the HQ3 form.

This is how it works:

- 1) Separate the pages of a Health Questionnaire 3 form and have your patient complete pg. 1 & 2.
- 2) Make sure "Re-Evaluation" is marked.
- 3) Scan HQ3 pages 1&2 and click "Documents" below or press the "Enter" key.
- 4) A "Warning" screen will appear letting you know that "Sheet 2" is missing.
- 5) From the options at the bottom of that screen, select "Ignore Sheet".
- 6) The "Forms Available" screen will appear. Make sure the "HQR" you just scanned is marked with an asterisk under the "Active" heading and click "OK".
- 7) The UPDATED information has been merged with the history from the patient's INITIAL Health Questionnaire and can be accessed by generating the "Re-Eval Patient History Summary" in the "Generate Documents" screen for that patient.

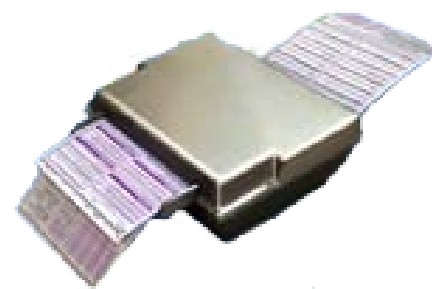

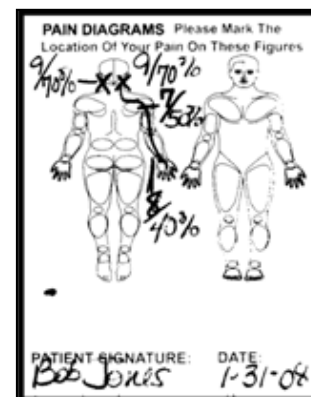
